# **Targeted Topics Forums**

Facilitating peer learning and exchange on the NAP process

The NAP Global Network's **Targeted Topics Forums** (**TTFs**) are a series of workshops that bring together representatives from developing countries and development cooperation agencies to facilitate learning and exchange on specific technical topics related to the National Adaptation Planning (NAP) process.

### What makes TTFs different from other workshops and training on adaptation planning and action?

**Who is in the room:** National adaptation planning and action involves a range of in-country actors including those outside of environmental agencies. Developing countries are invited to send teams of three representatives to participate in the event: one representative from the national ministry of planning or finance, one representative from a climate-sensitive sector of the economy and a third representative from the national ministry responsible for climate and environment. Representatives of development partner agencies—from both agency headquarters and regional offices—also participate in TTFs to learn how they can best support adaptation planning and action.

**Global scope:** The TTF convenes decision-makers and development partners from countries around the world: it's a space where adaptation practitioners can come together to exchange lessons on the unique adaptation challenges their countries face and discuss common strategies for overcoming these challenges.

**Sustained peer learning:** The TTF is not a one-off workshop; instead, once a country's team of adaptation practitioners has attended a TTF, we try to reconvene the same team alongside the same cohort of international peers. By reconvening international cohorts of adaptation specialists, the TTF contributes to building a community of peers who can support each other through ongoing learning and exchange on specific technical topics related to the NAP process.

## What happens at a typical TTF?

TTFs are structured to include a balance among the following three pillars that support learning on the topic in question:

- **Technical** inputs from experts in the field to enhance understanding and frame discussions.
- **Relational** opportunities for participants to share experiences on these issues and learn from their peers in countries from around the world.
- **Reflexive** opportunities for countries to unpack what these technical inputs mean in their own country contexts.

So far, we are addressing the following topics:

- Building political support for the NAP process,
- How to integrate adaptation planning and action across sectors and scales,
- How to finance NAP implementation
- Monitoring and evaluation in the NAP process.
