TERMS OF REFERENCE

Consultancy: Exploring the value of supporting Peer-to-Peer Learning as a Capacity Development Intervention

September-November 2021

Background

The National Adaptation Plan (NAP) Global Network is a multi-funder initiative that was established in 2014 to enhance climate adaptation planning processes in developing countries through capacity development, technical support, knowledge development and communication and coordination of bilateral support and in-country actors. Participants of the Network come from 141 countries and are primarily adaptation practitioners working on National Adaptation Plan processes. The secretariat of the Network is at the International Institute for Sustainable Development (IISD).

Assignment

Prepare a short briefing note exploring the value of supporting peer-to-peer learning as a successful intervention for capacity development for actors and development corporations involved in climate change adaptation and mitigation programming.

The briefing note aims to explore the importance of peer-to-peer learning and why it is relevant to climate change, the value added, the format of learning and how it contributes to capacity development as well as good principles. It should further explore different kinds of peer-to-peer learning approaches based on illustrative examples and make recommendations for donors and development corporations on how they could ensure/integrate good capacity development as part of their programming. The brief is intended to build on the experience of the NAP Global Network providing peer-to-peer learning opportunities (e.g., Peer Learning Summits, Targeted Topics Forums as well as virtual learning summit delivered in the past).

Expected Output:

- A 5–7-page policy brief (not including annexes and graphics)
